

Arthur Chesser (1900-1970)



rthur Chesser was born on 29 April 1900, the youngest of three sons of William Chesser (b. St John's Wood, 1867), a butcher's assistant, and his wife, Emma. Baptised at St Stephen's Church a year later, he lived with his parents and siblings at 126 Fairbridge road, Islington, north London, attending a local school. His eldest brother, Alfred, a solicitor's clerk, enlisted in the 8th Bn, Royal West Kent Regiment, but was killed in action in Flanders on 8 June 1916, aged 20.

Arthur himself trained as an engineer and saw service in what had become the RAF in the last months of the Great War. After the cessation of hostilities he returned to Islington and ran an engineering and toolmaking business at Stroud Green. In 1927 he married Ethel Mary Gurd (1899-1973), the youngest daughter of Edward James Gurd (1855-1916), a Marylebone grave digger, and Rose Ellen, *née* Read (1866-1937). Ethel's parents were descended from Wiltshire farming stock and had moved from Donhead St Andrew to Finchley, London, by February 1888, when they were married.

During World War II Arthur's engineering skills were put to good use at the Hawker Siddeley aircraft factory at Langley, Buckinghamshire, on the Hurricane assembly line; he also served as an ARP warden. Post-War, Arthur began to deal in copper, brass and other metals, later developing this line of business to incorporate antiques of all kinds. His home in Islington

is still remembered as "being packed with thousands of pairs of candlesticks, vases and all kinds of general antiques" and the coin dealer Brian Grover recalls that he first came across Arthur at Bermondsey Market in the early 1950s; Bermondsey was just one of the London markets where Arthur stalled out regularly until his death from pneumonia on 13 December 1970.

While antiques were business to Arthur, coins were a hobby. Initially he collected English crowns, then turned to halfcrowns, and eventually to larger denomination British Colonial coins. Jim Hardiman, then a schoolboy, remembers Arthur's regular visits to Portobello Road market, where he would show the Hardimans his latest coin acquisitions. The Hardimans brokered the sale of many of the Scottish countermarked dollars in the Chesser collection from the late Geoffrey Hearn; Hearn had acquired some of them at auction and others privately, explaining the absence of some pieces listed here from Manville's standard work. Another regular source for coins in this collection was the dealer Leonard Sverdloff (b.1894). An ex-Cossack who left Russia after the revolution in 1917, Sverdloff, who fought with the British Army in World War I and was a sergeant in the RAF in World War II, was noted as being a Russian interpreter at the time of his marriage to Mabel Farrer in 1944. Post-War, 'Sverdy', a chain-smoking stamp and coin dealer in Holloway, north London, was a regular at the rooms of Glendining's and Sotheby's from 1950 until his death on 4 July 1966.

On Arthur's death his coin collection was divided between his two sons. Many of his milled crowns reappeared on the market in Spink Auction 38 (10-11 October 1984, lots 179-254). What remains is still a remarkable group of English and Scottish silver coins, testament to what could be acquired through a network of contacts in the late 1950s and early 1960s. Many, regrettably, have no provenance that can be proven as sale catalogues and dealers' lists were not profusely illustrated at that time but, regardless of that, there is plenty in the following 408 lots to tempt beginner and advanced collector alike. **P.J.P-M.**

The real purpose of these pieces is not now known. Rayner, in *ESC* (p.33) maintains the time-honoured view that they were patterns for a crown executed *c*. 1828 and dispels the notion inferred by Linecar and Stone's repetition of a century-old attribution to the engraver John Milton, who had died in 1805 (p.69). Brown (p.270) speculates that they were issued in connection with George IV's coronation in July 1821. Many of the specimens seen carry the initial M on the lower reverse, perhaps indicative of an association with either Jean-Baptiste Merlen, George Mills or James Mudie (*cf.* DNW 27, lot 498 and Goldberg Auction 32 (Beverly Hills), 21 September 2005, lot 3429)






2 Minimum increment

3 The premium

11 Remedies for non-payment or failure to collect purchase

(a) to proceed against the buyer for damages for breach of contract.

(b) to rescind the sale of that or any other lots sold to the defaulting buyer at the same or any other auction.

(c) to re-sell the lot or cause it to be re-sold by public auction or private sale and the defaulting buyer shall pay to Dix Noonan Webb any resulting deficiency in the 'total amount due' (after deduction of any part payment and addition of re-sale costs) and any surplus shall belong to the seller.

If Dix Noonan Webb is satisfied that the item is a 'deliberate forgery' and that the buyer has and is able to transfer a good and marketable title to the lot free from any third party claims, the sale will be set aside and any amount paid in respect of the lot will be refunded, provided that the buyer shall have no rights under this Condition if:

13 Warranty of title and availability

14 Reserves

25 Any representation or statement by Dix Noonan Webb, in any catalogue as to authorship, attribution, genuineness, origin, date, age, provenance, condition or estimated selling price is a statement of opinion only. Every person interested should exercise and rely on his or her own judgement as to such matters and neither Dix Noonan Webb nor its servants or agents are responsible for the correctness of such opinions.

26 Whilst the interests of prospective buyers are best served by attendance at the auction, Dix Noonan Webb will, if so instructed, execute bids on their behalf. Neither Dix Noonan Webb nor its servants or agents are responsible for any neglect or default in doing so or for failing to do so.

27 Dix Noonan Webb shall have the right, at its discretion, to refuse admission to its premises or attendance at its auctions by any person.

28 Dix Noonan Webb has absolute discretion without giving any reason to refuse any bid, to divide any lot, to combine any two or more lots, to withdraw any lot from the auction and in case of dispute to put up any lot for auction again.

29 (a) Any indemnity under these Conditions shall extend to all actions, proceedings costs, expenses, claims and demands whatever incurred or suffered by the person entitled to the benefit of the indemnity.

(b) Dix Noonan Webb declares itself to be a trustee for its relevant servants and agents of the benefit of every indemnity under these Conditions to the extent that such indemnity is expressed to be for the benefit of its servants and agents.

30 Any notice by Dix Noonan Webb to a seller, consignor, prospective bidder or buyer may be given by first class mail or airmail and if so given shall be deemed to have been duly received by the addressee 48 hours after posting. 31 These Conditions shall be governed by and construed in accordance with English law. All transactions to which these Conditions apply and all matters connected therewith shall also be governed by English law. Dix Noonan Webb hereby submits to the exclusive jurisdiction of the English courts and all other parties concerned hereby submit to the non-exclusive jurisdiction of the English courts.

32 In these Conditions:

(a) 'catalogue' includes any advertisement, brochure, estimate, price list or other publication;
