- 4** Penny, Profile Right type [BMC VII], Wareham, Godwine, GOD[—]E ON PERA, 0.97g/12h (Allen, BNJ 2012, p.82; N 847; S 1256). Fine or better but cracked and repaired £200-£260

Only ten coins of Ludica are known; all the others are without a mint signature, struck by the moneyers Eadgar, Eadnoth and Werebald at an uncertain East Anglian mint, possibly Ipswich. This unique example of the ruler's London coinage stands out as the most significant both numismatically, and in terms of informing our understanding of Mercian history. The mint-signature on the reverse clearly demonstrates that the Mercians continued to hold London throughout the mid to late 820s, and that the city was not captured by Ecgbert until at least after Ludica's death in 827. In light of the existence of this coin it is now clear that Ecgbert's own LVNDONIA CIVIT coinage (Naismith 2011 L30a) was designed not as a remarkable celebratory issue following the capture of London, but instead as a way of suggesting monetary continuity with his defeated Mercian foe.

Equally significant is the portrait of Ludica on the obverse. Bold and almost naturalistic in style, the image stands in contrast not only to the other coins of Ludica, but also those struck under his predecessors at London. When taken together with the reference to LVNDONIA CIVIT on the reverse, it is tempting to see this as a sign of lingering Roman Influence on Anglo-Saxon kingship. Perhaps during his brief and conflict-ridden reign Ludica drew inspiration from the legacy left by his revered Roman predecessors in an attempt to consolidate his own authority.

The real purpose of these pieces is not now known. Rayner, in *ESC* (p.33) maintained the time-honoured view that they were patterns for a crown executed c. 1828 and dispels the notion inferred by Linecar and Stone's repetition of a century-old attribution to the engraver John Milton, who had died in 1805 (p.69). Brown (p.270) speculates that they were issued in connection with George IV's coronation in July 1821. (b) The buyer shall be responsible for any removal, storage and insurance charges on any lot not taken away within 5 working days after the day of the auction.

(c) to re-sell the lot or cause it to be re-sold by public auction or private sale and the defaulting buyer shall pay to DNW any resulting deficiency in the 'total amount due' (after deduction of any part payment and addition of re-sale costs) and any surplus shall belong to the seller.

(d) to remove, store and insure the lot at the expense of the defaulting buyer and, in the case of storage, either at DNW's premises or elsewhere.

If circumstances do not permit DNW to take instructions from the seller, the seller authorises DNW at the seller's expense to agree special terms for payment of the 'total amount due', to remove, store and insure the lot sold, to settle claims made by or against the buyer on such terms as DNW shall in its absolute discretion think fit, to take such steps as are necessary to collect monies due by the buyer to the seller and if necessary to rescind the sale and refund money to the buyer if appropriate.

19 If, notwithstanding that, the buyer fails to pay to DNW the 'total amount due' within three weeks after the auction and DNW remits the 'sale proceeds' to the seller, the ownership of the lot shall pass to DNW.

### 20 Charges for withdrawn lots

26 Whilst the interests of prospective buyers are best served by attendance at the auction, DNW will, if so instructed, execute bids on their behalf. Neither DNW nor its servants or agents are responsible for any neglect or default in doing so or for failing to do so.

27 DNW shall have the right, at its discretion, to refuse admission to its premises or attendance at its auctions by any person.

28 DNW has absolute discretion without giving any reason to refuse any bid, to divide any lot, to combine any two or more lots, to withdraw any lot from the auction and in case of dispute to put up any lot for auction again.

29 (a) Any indemnity under these Conditions shall extend to all actions, proceedings costs, expenses, claims and demands whatever incurred or suffered by the person entitled to the benefit of the indemnity.

(b) DNW declares itself to be a trustee for its relevant servants and agents of the benefit of every indemnity under these Conditions to the extent that such indemnity is expressed to be for the benefit of its servants and agents.

30 Any notice by DNW to a seller, consignor, prospective bidder or buyer may be given by first class mail or airmail and if so given shall be deemed to have been duly received by the addressee 48 hours after posting.

31 These Conditions shall be governed by and construed in accordance with English law. All transactions to which these Conditions apply and all matters connected therewith shall also be governed by English law. DNW hereby submits to the exclusive jurisdiction of the English courts and all other parties concerned hereby submit to the non-exclusive jurisdiction of the English courts.

### 32 In these Conditions:

(a) 'catalogue' includes any advertisement, brochure, estimate, price list or other publication;

(b) 'hammer price' means the price at which a lot is knocked down by the auctioneer to the buyer;

(c) 'total amount due' means the 'hammer price' in respect of the lot sold together with any premium, Value Added Tax chargeable and additional charges and expenses due from a defaulting buyer in pounds sterling;
